

SUMMARY: The document below is the Prerogative Court of Canterbury copy of the will, dated 17 June 1532 and proved 8 July 1532, of Sir William Spencer (d. 22 June 1532), whose wife's nephew was Sir Richard Knightley (1533-1615), at whose home at Fawsley, Northamptonshire, Martin Marprelate's *Epitome* was printed in November 1588.

### ***FAMILY BACKGROUND***

The testator was the son of Sir John Spencer (d. 14 April 1522) and Isabel Graunt (d.1558). For the will of the testator's father, Sir John Spencer, see TNA PROB 11/20/348. For the will of the testator's mother, Isabel (nee Graunt) Spencer, see TNA PROB 11/40/348.

*Here lieth the bodies of Sir John Spencer, knight, and Dame Isabel, his wife, one of the daughters and coheirs of Walter Graunt of Snitterfield in the county of Warwick, esquire. Her mother was the daughter and heir of Humphrey Ruddinge of the Wich in the county of Worcester, esquire. Which John and Isabel had issue Sir William Spencer, knight; Anthony Spencer, who died without issue; Jane, wife to Richard Knightley, esquire, son and heir of Sir Richard Knightley of Fawsley in the county of Northampton, knight; Isabel, married to Sir Nicholas Strelley of Strelley in the county of Nottingham, knight; Dorothy, married to Sir Richard Catesby of Legers-Ashby in the county of Northampton, knight. Which Sir John Spencer departed this life, the 14<sup>th</sup> of April Anno Domini 1522.*

### ***MARRIAGE AND ISSUE***

The testator married Susan Knightley, the daughter of Sir Richard Knightley (d. 8 December 1534) by Joan or Jane Skenard (d.1539), the daughter and heir of Henry Skenard or Skynnerton, son and heir of Ralph Skynnerton of Alderton,

*Susan Knightley (d.1549+) was the daughter of Sir Richard Knightley of Fawsley, Northamptonshire (c.1500-December 8, 1534) and Jane Skennard (d.1539). She married Sir William Spencer of Althorp, Northamptonshire and Wormleighton, Warwickshire (d. June 22, 1532) and was the mother of John (1524-1586), Isabel (1515-1578), Jane (d.1593), Dorothy (d.1575), Anne, and Mary. Her brothers Richard and Edmund quarreled with her husband and, after an alleged assault on them by Sir William as they were leaving the Horse's Head in Cheapside in 1529, the case went to the Star Chamber. After Spencer died, however, they supported their sister's effort to withhold her son's wardship from the Crown and defraud the trustees of the estate of certain movables. Susan claimed that her husband had been deeply in debt at his death, although the estate was valued at £454 a year when her son reached his majority, and that she and her children were destitute. Edmund Knightley was charged with fraud and was briefly imprisoned in the Fleet in September 1532. The wardship was granted to Sir Giles Alington in December 1539.*

As noted above, the testator quarrelled in 1529 with his wife's relatives. In a pleading filed in the Star Chamber it is stated that the testator suspected his father-in-law, Sir Richard Knightley, and his brother-in-law, Sir Edmund Knightley (by 1491 – 12 September 1542), of having procured the Bishop of Lincoln to cite the testator for 'certain criminal offences', whereupon the testator attacked Sir Edmund Knightley in Cheapside. By Susan Knightley the testator had a son and five daughters. See *The English Baronetage*, *supra*, p. 205:

*Here lieth the bodies of Sir William Spencer, knight, and Dame Susan, his wife, daughter of Sir Richard Knightley of Fawsley in the county of Northampton, knight, and had issue by her Sir John Spencer, knight, their only son; Isabel, married to Sir John Cotton of Landwade in the county of Cambridge, knight; Jane, wife to Sir Richard Bruges of Shefford in the county of Berkshire, knight; Dorothy, married to Thomas Spencer of Everton in the county of Northampton, esquire; Anne, wife to Sir John Goodwin of Winchendon in the county of Buckingham, knight, which Anne died without issue; Mary, wife to Thomas Boles of Wallington in the county of Hertford, esquire. Which Sir William died the 22<sup>nd</sup> day of June, Anno Domini 1532.*

By indentures dated 27 July 1532, custody of Sir John Spencer's lands was granted during his minority to Sir Nicholas Strelley, Sir Walter Smyth (d. 15 May 1554), Sir Anthony Cope (d. 5 January 1551) and John Onley (by 1498-1537), all of whom appear to have been his relations. See:

- A. 12847. (1) *Counterpart indenture, 22 February, 30 Henry VIII, between Sir William Poulet, knight, master of the king's wards, on the king's behalf, of the one part, and Sir Nicholas Stirley, knight, Sir Walter Smithe, knight, and Anthony Cope, esquire, of the other, witnessing that, whereas by a pair of former indentures, dated 27 July, 24 Henry VIII, between Poulet of the one part and Stirley, Smithe, Cope and John Only, esquire, of the other, it was agreed for the king's grant, by letters patent under the great seal, to be made to Stirley and the others, of the custody of the castles, manors, lordships, &c. that late belonged to Sir William Spencer, knight, deceased, they paying 200l. rent for the lands in possession, and the accustomed farms for reversions as they fell in; the said Stirley, Smithe, Cope [and Onlie interlineated throughout] covenant that the king shall have reserved to him thereout all 'greate woddes, mariages and reliefes,' that they will cut no underwood under ten years growth, that after cutting they will keep such underwood fenced for six years, that they will keep in repair 'manor places, parke pales, hedges and ditches,' and 'preserve convenient dere within the same parkes,' that they will pay Sir William's debts as far as his goods will go, that they will pay the legacies yearly bequeathed to John Spencer, Sir William's son and heir, and will keep and maintain the residue of Sir William's children in meat, drink, lodging, learning and apparel, suitable to their degree and age, that they will pay 200l. at least to the marriage of every of his daughters,*

*marrying with their consent, being not the king's wards, this last covenant to be void if John Spencer die without issue before his sisters' marriages, that they will 'redeame of thandes of William Browne to the said John Spencer and his heires the manor of Stonnton,' co. Northampton, this side the Purification, 1535, that they will pay to the treasurer of the king's chamber 1,000 marks, at certain days of payment, for their fine, &c. Signed Nycolas Strelley, Walter Smyth, Anthonye Coope.*

B. Memorandum endorsed that Sir William Poulet shall have yearly 'one bukke and one doe of season out of the Spencers parkes within wryttyn.'

*Isabel Spencer (1515-November 2, 1578) was the daughter of Sir William Spencer of Althorp, Northamptonshire (d. June 22, 1532) and Susan Knightley (d.1539). In his will, proved July 8, 1532, her father provided for his daughters until they married and left each of them five hundred marks, so long as they heeded the advice of his executors in choosing their husbands. Isabel's mother was one of the executors. Isabel married Sir John Cotton of Landwade and Cheveley, Cambridgeshire (1512/13-April 21, 1593). They had eight sons and five daughters, including John (c.1543-1620/1), Frances, Robert, Alice, Anne, Sarah, and Edmund. Portrait: effigy in the north chapel at Landwade.*

*Cope, Sir Anthony (1486/7–1551), landowner and courtier, was the second recorded son of William Cope (c.1440–1513), cofferer to Henry VII, of Bedhampton, Hampshire, and Hanwell, Oxfordshire, and an unknown second wife. His father married three times, and Anthony had at least one elder half-brother, Stephen, one brother, and four younger stepsisters (one of whom became Stephen's wife) who were the daughters of William Cope's third wife, Johane Spencer.*

In the name of God, Amen. I, William Spencer, knight, make and ordain my last will and testament the 17 day of June the 24<sup>th</sup> year of our Sovereign Lord King Henry the 8<sup>th</sup> in manner & form following:

First I bequeath my soul to Almighty God, to Our Lady Saint Mary, & to all the holy company of heaven, & my body to be buried in the parish church of Brington as it shall be thought most convenient by mine executors;

Item, I will that my father[<sup>s</sup>] will be performed in every article of the same that is not yet performed;

Item, I will that all my debts be truly content and paid;

Item, I will that my manor of Stonton & all my lands in Stonton be redeemed in such wise that my said manor, lands & tenements in Stonton aforesaid may stand clear of all encumbrances by me made at the time that my son & heir shall come to th' age of 21 years;

Item, I give and bequeath to every one of my daughters five hundred marks of gold [sic?] and lawful money of England towards their marriages if the[y] be married by the advice of mine executors;

Item, I will that mine executors glaze the new chapel at Brington according to their discretion;

Item, I will that mine executors find an honest priest to sing for me in the said chapel by the space of five years next after my decease;

Item, I will that John Spencer, my son and heir, have yearly to his finding ten pounds till he come to [-to] the age of 18 years, and after that he hath accomplished the age of 18 years, then he to have £20 by year till he come to his full age of 21 years;

Item, I will that my burial and ceremonies of the same be made according to the mind of mine executors;

Item, I will that my servants be truly content and paid of their wages, & that they continue in service with mine executors at their costs and charges for one year next after

my decease if they be so content, taking for their wages not above forty shillings the best with his livery;

Item, I will that all patents, leases & grants for term of years made by me to any of my servants be good, & that they enjoy them according to their patents, leases and grants for term of years, life or otherwise;

Item, I will that all my goods and chattels & the profits of all my lands & tenements within the realm of England go to the performance of this my last will and testament, and that my feoffees of all my lands & tenements make estate of all my said lands & tenements to the use and performance of this my last will and testament in such wise as it shall be devised by them or by the counsel learned of mine executors;

Item, I will that my daughters have their sufficient finding of the issues and profits of my lands and tenements aforesaid by the discretion of mine executors till the day of their marriages so that they be married before my son, John, come to the age of 21 years;

Item, I give to Isabel, my maid, beside her wages, 40s;

Item, I give Edith, my maid, 20s;

I give Katherine, my maid, 20s;

Item, I give to Edward Cartwright £6 13s 4d;

Item, I give unto John Griffyn £40;

Item, I revoke & renounce all former wills & testaments by me afore made;

item, I will that all the costs and charges that mine executors shall sustain by reason of this my last will and testament shall be borne of the issues and profits of all my said lands and tenements;

Item, I will that my will fully performed, mine executors shall leave my grounds storn [=stored?] sufficiently to John, my son, after the age of 21 if they conveniently so may;

Item, I ordain & make mine executors Dame Susan Spencer, my wife, Sir Nicholas Strelley, knight, Anthony Cope, esquire, Walter Smythe, esquire, John Onley, gentleman, and Thomas Banister, gentleman, and I would that they shall have for their painstaking each of them forty pounds;

Witnesses at the sealing hereof Sir Thomas Lodbroke, his(?) ghostly father, and Mr Robert Singylton, Edward Comburford, Thomas Preston, with other mo [=more].

[=The above-written testament was proved before the Lord at Lambeth on the 8<sup>th</sup> day of the month of July in the year of the Lord the thousand five hundred 32<sup>nd</sup> by the oath of Nicholas Strelley, knight, and Anthony Cope, esquire, executors named in the same testament, and probated etc., and administration was granted of all and singular the goods of the said deceased to the mentioned executors, Nicholas and Anthony, etc., sworn on the Holy Gospels to well and faithfully etc., and to [+exhibit] a full and faithful inventory of all and singular the goods etc., and also to render a plain and true account etc., with power reserved for a similar grant to be made to the other executors named in the same testament when they shall have come etc. On the seventh day of the month of August in the year of the Lord abovesaid a similar grant was made of the goods of the said deceased to Lady Susan, relict, and Thomas Banister, executors etc., sworn in the person of Master Robert Jonson, their proctor, etc.]
