

SUMMARY: The document below is the nuncupative will, dated 8 February 1588 and proved 17 February 1588, of Oxford's maternal uncle, William Golding, brother of Oxford's mother, Margery Golding (d.1568).

FAMILY BACKGROUND

For the testator's parents and siblings, see the will of his father, John Golding, TNA PROB 11/32/177.

MARRIAGE AND ISSUE

The testator married Elizabeth West (d. by 22 June 1591), the granddaughter of Thomas West (d. August 1508), and the daughter and co-heir of Edmund West (d.1530?) of Cornard, Suffolk. See Golding, Louis Thorn, *An Elizabethan Puritan*, (New York: Richard R. Smith, 1937), pp. 14-15. See also the will of Thomas West, TNA PROB 11/16/187.

In his will Thomas West requested that Sir William Waldegrave (c.1465 - 30 June 1527) have the 'rule and marriage' of his eldest son, and in 1519 Sir William Waldegrave sold the wardship of Edmund West to Margaret (nee Felton) Drury, widow of John Drury (1456-1499?) of Rougham, Suffolk, who married him to her daughter, Dorothy Drury. By Dorothy Drury, Edmund West had two daughters:

-Margaret West, who married Edmund Danyell (d.1569), esquire, of Acton. For her will, dated 27 September 1587 and proved 30 April 1589, in which she mentions her 'sister Golding', her sister's two daughters, Margery Golding and Mary Golding, and 'my sister Felton', see TNA PROB 11/73/483. For the will of the testator's brother-in-law, Edmund Danyell, dated 29 August 1569 and proved 11 November 1569, in which he mentions his 'brother William Golding', see TNA PROB 11/51/382.

-Elizabeth West (d. by 22 June 1591), who married firstly John Bokenham (d.1566), and secondly the testator, William Golding.

After the death of Edmund West, Dorothy Drury married secondly Robert Downes of Melton, Norfolk.

For a bequest to the testatrix' wife as one of the two daughters of Edmund West, see the will of Edward Waldegrave (d.1545?), TNA PROB 11/30/620:

Item, I give to the two daughters of Edmund West after the decease of me and my wife two acres of land di(?) called Gilbertes crofts which I bought of Martyn and other if they make no sale of no part of Greyes ground.

By Elizabeth West, the testator had two daughters:

* **Margery Golding.**

* **Mary Golding.**

Administration of the testator's estate was first granted to his widow, Elizabeth (nee West) Buckenham Golding. A note in the margin of the will indicates that by 22 June 1591 she had died, and administration was granted to their daughter, Mary Golding.

This is the will nuncupative of William Golding of Belchamp St Paul in the county of Essex, esquire, inhabiting within the jurisdiction of the Dean and Chapter of the Cathedral Church of Saint Paul, London, the eighth day of February in the year of our Lord God a thousand five hundred fourscore and seven in the thirtieth year [=8 February 1588] of the reign of our Sovereign Lady Queen Elizabeth etc. in the presence of us whose names are underwritten, viz., first the said William Golding, calling for Elizabeth, his wife, said unto her, Bess, I have nothing to give thee in consideration of the long time that thou hast been with me, but I would you should have all that I have, and I pray you

pay my debts and have consideration of my daughters, and then the said Elizabeth answered, sir, I will pay your debts if I sell all that I have to my smock, and after the said William Golding, about three of the clock in the night following, died at his house in Belchamp Saint Paul aforesaid. William Maslevile, James Armond.

[=On the seventeenth of February in the year of the Lord according to the course and reckoning of the English Church a thousand five hundred eighty seven [=17 February 1588] a commission issued to Elizabeth Golding, relict of the said deceased, having while he lived and at the time of his death goods, rights or credits in divers particular dioceses or jurisdictions, to administer the goods, rights and credits of the same according to the tenor of the above-written testament, sworn on the Holy Gospels to well and faithfully administer etc. in the person of Peter Johnson, notary public, her proctor etc.]

[=On the 22nd day of June 1591 a commission issued to Mary Golding, natural and legitimate daughter of the said deceased, to administer the goods, rights and credits of the said deceased (according to the tenor of the same testament) not administered(?) by Elizabeth, relict and administrator, now deceased, sworn to well etc. in the person of Thomas Lovell, notary public, proctor etc.]
