

SUMMARY: The document below is a detailed summary of revenues received on Oxford's behalf during the first five and a half years of his wardship from manors and lands which came to him as a joint-purchaser with his father. In the legal language of the day, a purchaser was someone who acquired property, especially land, in any way other than by inheritance. The document is a very significant one because the net revenues for the manors in question correspond closely with the net yearly rental values given in the 16th Earl's inquisition post mortem (TNA C 142/136/12) and in TNA WARD 8/13, thus establishing decisively that the values placed on Oxford's inheritance in those documents were not under-valuations. See also TNA SP 12/33/32, which also deals with the lands which came to Oxford as purchaser.

As indicated at the end of the document, the total actual net revenue received from these properties for the first five and a half years of Oxford's wardship was £1999 11-1/2d di qua iijto pars qua, with £47 14s 11-1/2d in outstanding arrearages. The average actual net income from these properties was thus approximately £372 a year. The accounts appear to balance to the penny, apart from a discrepancy of £1 in the account for Thornecombe and £5 for Castle Camps. A summary by manor, and by officer, is provided immediately below for ease of reference.
