SUMMARY: The document below is the copy on the Close Rolls of a recognizance in the amount of £400 acknowledged by Oxford to Edward Atslowe (d.1594) on 15 August 1579. The recognizance is struck through, and cancelled by a vacat in the left margin dated 31 October 1584. The document has the signatures of Edward Atslowe and Gilbert Gerard, Master of the Rolls.

For another recognizance in the amount of £500 acknowledged by Oxford to Edward Atslowe (d.1594) on 15 August 1579 in connection with indentures of the same date, see TNA C 54-1065, Part 19.

On 2 November 1573 Edward Atslowe had married Oxford's cousin-german, Frances Wingfield (d. 1605), at Stoke Newington. In 1584 Atslowe purchased the manor of Downham from Oxford in the name of his son Henry (see TNA CP 25/2/132/1696/27ELIZIHIL, Item 29). The recognizance below provides that Oxford is to pay Atslowe £400 on 25 December 1579. However the condition states that the recognizance will be void if Oxford pays Atslowe £200 on 24 June 1591 at the Chapel of the Rolls. This unusual penalty, which provides that £400 is to be paid within four months, but if not, only £200 need be paid twelve years later, suggests that there is more to this recognizance than meets the eye. It may be that the recognizance served as a guarantee that Oxford would eventually sell the manor of Downham to Atslowe.

## LM: Recognizance between the Earl of Oxford & Atslowe

Edward de Vere, Earl of Oxford, Viscount Bulbeck, Lord Scales & Badlesmere and Lord Great Chamberlain of England, having appeared personally before the Lady Queen in her Chancery, acknowledged himself to owe to Edward Atslowe of London, esquire, Doctor in Medicines, four hundred pounds of lawful money of England, to be paid to the same Edward Atslowe, his executors, administrators or assigns on the feast of the Birth of the Lord next to come after the date of these presents;

And if he shall not have done [+so], the foresaid Earl wishes & grants for himself, his heirs, executors & administrators that the said sum of money be levied of his lands & tenements, goods & chattels wheresoever they may be found within the kingdom of England to the use & behoof of the same Edward Atslowe, his executors, administrators & assigns;

Witness the Queen at Westminster on the fifteenth day of August in the twenty-first year of the reign of our Lady Elizabeth by the grace of God of England, France & Ireland Queen, Defender of the Faith etc.

The condition of this recognizance is such that if the above-bounden the right honourable the Earl of Oxenford, his executors, administrators or assigns or any of them, do well and truly content and pay or cause to be contented and paid unto the above-named Edward Atslowe, his executors or assigns, the sum of two hundred pounds of lawful money of England on the feast-day of the Nativity of Saint John Baptist which shall be in the year of Our Lord God one thousand five hundred fourscore and eleven at or in the Chapel of the Rolls in or near Chancery Lane in the suburbs of the city of London without fraud or covin, that then this present recognizance to be void and of none effect, or else it to stand and remain in full strength and virtue.

[=This recognizance vacated, together with the condition of the same, because on the 31<sup>st</sup> day of October in the twenty-sixth year of the reign of the Lady Queen Elizabeth the within-written Edward Atslowe came personally before the same Lady Queen in her Chancery & confessed himself to be completely satisfied & paid of all sums of money in the recognizance & condition contained & specified; therefore at the request of the foresaid Edward Atslowe the recognizance was cancelled & annulled.]
