

SUMMARY: The document below is the copy on the patent rolls of the letters patent dated 1 July 1587 by which the Queen granted certain lands of the attainted Babington conspirator Edward Jones to Oxford's brother-in-law, Robert Cecil, and Oxford's servant, Hugh Beeston, for Oxford's benefit. A letter from Lord Burghley to Sir Francis Walsingham of 13 May 1587 indicates that the use of Cecil and Beeston as intermediaries was necessary in order to protect the grant from Oxford's creditors.

Most of the lands included in the grant were located in and around the town of Wrexham in Denbigh in North Wales. What Oxford did with the lands after the Queen's grant of 1 July 1587 is unknown, although it seems likely he sold them. Lord Burghley indicates in a letter of 13 May 1587 that that was Oxford's intention (see TNA SP 12/201/3, ff. 4-6).

LM: Grant to Robert Cecil, esquire, & Hugh Beeston the younger

The Queen to all to whom etc. greeting. Know ye that we, at the humble petition of our well-beloved & faithful cousin Edward, Earl of Oxford, of our especial grace and of our certain knowledge & mere motion have given & granted, and by these presents for us, our heirs & successors, do give & grant to our beloved subjects Robert Cecil, esquire, & Hugh Beeston the younger, servant of Edward, Earl of Oxford, all those our messuages, lands, tenements & hereditaments whatsoever with the appurtenances situate, lying or being in the town, fields, parishes or hamlets of Bersham in the county of Denbigh which lately were parcel of the possessions of Edward Jones lately attainted of high treason, and which were forfeited to us by the attainer of the same Edward Jones;

And all those our messuages, lands, tenements & hereditaments whatsoever with the appurtenances situate, lying or being in the town, parishes or fields of Chwthremis in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones lately of high treason attainted, and which were forfeited to us by the foresaid attainer of the same Edward Jones;

And all those our messuages, lands, tenements & hereditaments whatsoever with the appurtenances situate, lying & being in the town, fields, parishes or hamlets of Esclusham in our said county of Denbigh which lately were parcel of the possessions of the foresaid Edward Jones lately of high treason attainted, and which were forfeited to us by the foresaid attainer of the same Edward Jones;

And all that capital messuage called Plas Cadogan with the appurtenances in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones, and which were forfeited to us by the foresaid attainer of the same Edward Jones;

And all those our messuages, mills, houses, lands, tenements & hereditaments situate, lying or being in Esclusham aforesaid to the said capital messuage called Plas Cadogan in the said county of Denbigh belonging or appertaining or with the same capital messuage being used or occupied which lately were parcel of the possessions of the said Edward Jones lately attainted of high treason, and which were forfeited to us by the foresaid attainer of the same Edward Jones;

And all those our messuages, lands, tenements & hereditaments situate, lying or being in the parishes, town or fields of Chrionyth in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones, and which were forfeited to us by the foresaid attainer of the same Edward Jones;

And all those our messuages, mills, lands, tenements & hereditaments whatsoever with the appurtenances situate, lying & being in the parishes, town or fields of Morton Anglicorum in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones lately attainted of high treason, and which were forfeited to us by the foresaid attainer of the same Edward Jones;

And all those our lands, tenements & hereditaments with the appurtenances situate, lying & being in Gresford in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones, and which were forfeited to us by the foresaid attainer of the same Edward;

And all those our messuages, lands, tenements & hereditaments whatsoever with the appurtenances situate, lying & being in Acton in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones, and which were forfeited to us by the foresaid attainer of the same Edward;

And all those our messuages, lands, tenements & hereditaments whatsoever with the appurtenances situate or being in Trevor in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones, and which were forfeited to us by the foresaid attainer of the same Edward;

And all those our messuages, lands, tenements & hereditaments whatsoever situate, lying & being in Bodon Wydog in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones lately attainted of high treason, and which were forfeited to us by the foresaid attainer of the same Edward;

And all those our messuages, lands & tenements whatsoever with the appurtenances situate & being in Kymmo in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones lately attainted of high treason, and which were forfeited to us by the foresaid attainer of the same Edward Jones;

And all those our messuages, lands & tenements whatsoever with the appurtenances situate, lying & being in the town, parishes or fields of Marchwiel in our said county of Denbigh which lately were parcel of the possessions of the foresaid Edward Jones lately attainted of high treason, and which were lately forfeited to us by the foresaid attainer of the same Edward;

And all those our messuages, lands, tenements & hereditaments whatsoever with the appurtenances situate & being in Rwigton in our said county of Denbigh which lately were parcel of the possessions of the said Edward Jones, and which were forfeited to us by the foresaid attainer of the same Edward;

We do give also and by these presents of our more abundant grace and of our certain knowledge & mere motion for us, our heirs and successors, do grant to the forenamed Robert Cecil and Hugh Beeston, their heirs and assigns, all that our whole capital messuage with the appurtenances, and all our lands, meadows, grazing lands, pastures & hereditaments whatsoever with the appurtenances situate & being in Penley in our county of Flint which lately were parcel of the possessions of the said Edward Jones, and which were forfeited to us by the foresaid attainer of the same Edward;

And all those our other manors, rectories, advowsons, messuages, mills, houses, lands, tenements, rents, reversions, services, tithes, profits, commodities & hereditaments whatsoever situate, lying & being in our counties of Denbigh, Flint & Shrewsbury or in any of them which lately were parcel of the possessions & hereditaments of the said Edward Jones lately attainted of high treason, and which were forfeited to us by the foresaid attainer of the same Edward;

And all & singular those our reversions, remainders, estate, title, right, interest & claim whatsoever of or in the foresaid manors, rectories, messuages, mills, lands, tenements,

hereditaments & the rest of the premises by these presents granted beforehand and any of them which (f. & n.) we, our heirs & successors, or any of us have or ought to have by reason of the foresaid attainder of the same Edward Jones;

And also the rents & yearly profits whatsoever of all & singular the premises of them by these presents granted beforehand & of any parcel thereof, and the rents & yearly profits whatsoever reserved upon whatsoever leases & grants made of the same premises or of any parcel thereof;

We do give also and by these presents of our more abundant grace [+] of our certain knowledge & mere motion for us, our heirs & successors, do grant to the forenamed Robert Cecil & Hugh Beeston all & all manner of obligations, deeds, writings & muniments concerning or touching the premises or any parcel thereof;

And all and all manner our woods, underwoods, mines, quarries & arbours whatsoever arising or being of, in & upon all the premises by these presents granted beforehand or any parcel thereof;

And the whole land, ground & soil of the same woods, underwoods & arbours & of any parcel thereof;

To have, hold & enjoy the foresaid manors, messuages, lands, tenements and other all & singular the premises above by these presents beforehand granted with all & singular their entire appurtenances to the forenamed Robert Cecil & Hugh Beeston, their heirs & assigns, to the proper behoof & use of themselves, Robert Cecil & Hugh Beeston, their heirs & assigns, forever, without any account to be rendered or made to us, our heirs or successors;

To hold all & singular such the foresaid manors, messuages, lands, tenements & the rest of all & singular the premises above by these presents granted beforehand with all & singular their appurtenances which previously were held of us by the foresaid Edward Jones, of us, our heirs & successors, by such, the like & the same several rents & services by which & as the forenamed Edward Jones formerly held them, & not by others;

And to hold all other the foresaid manors, rectories, lands, tenements & hereditaments which formerly were held by the foresaid Edward Jones from any other person or any other persons of us, our heirs & successors, as of our manor of East Greenwich in our county of Kent by fealty only in free & common socage, & not in chief nor by knight-service;

And further of our more ample grace and of our certain knowledge & mere motion we have given & granted and by these presents for us, our heirs & successors, do give and grant to the forenamed Robert Cecil & Hugh Beeston, their heirs & assigns, that the same Robert Cecil & Hugh Beeston, their heirs & assigns, henceforth forever might have, hold & enjoy and might have power & be able to have, hold & enjoy within the foresaid manors, rectories and other the premises by these presents beforehand granted and within

any parcel thereof so many, the same, such [+&] the like kinds of courts, leets, views of frankpledge, law-days, and assize & assizes of bread, wine & ale, and also chattels waived, estrays, chattels of felons & fugitives, felons of themselves & put in exigent, knights' fees, estovers, rights, jurisdictions, franchises, liberties, privileges, customs, profits & commodities whatsoever how many, how much, what, and as fully, freely & entirely and in as ample manner & form as the foresaid Edward Jones, formerly being seised of the same manors, messuages, lands, tenements & other the premises or of any parcel thereof at any time had, held or enjoyed or ought to have, hold or enjoy within the same manors, messuages, lands, tenements & the rest of the premises or within any parcel of them by reason or means of any writing, gift, grant or confirmation or of any our letters patent by us or by any of our ancestors [+within] the kingdom of England formerly made or granted or confirmed, or by reason or means of any prescription, use or custom formerly lawfully had or used, or by any lawful manner, right or title whatsoever;

And further of our more abundant grace and of our certain knowledge & mere motion we have given and granted, and by these presents for us, our heirs and successors, do give & grant to the forenamed Robert Cecil & Hugh Beeston all the issues, rents, revenues & profits of all & singular the premises above expressed & specified and by these presents beforehand granted & of any parcel thereof from the feast of Saint John the Baptist last past hitherto resulting or arising, to have to the same Robert Cecil and Hugh Beeston of our gift without account or any other thing therefore in any wise to be yielded, paid or made to us, our heirs or successors;

And further of our more ample grace and of our certain knowledge and mere motion we will and by these presents do grant for us, our heirs & successors, to the forenamed Robert Cecil & Hugh Beeston, their heirs & assigns, that we, our heirs & successors, forever yearly & from time to time will discharge & acquit & save harmless as well the forenamed Robert Cecil & Hugh Beeston, their heirs & assigns, as the foresaid manors, lands, tenements & other the premises with the appurtenances against us, our heirs & successors, from all & all manner rents, fees, annuities, pensions, portions, sums of money and all things whatsoever issuing or to be paid from the premises or any parcel thereof to us, our heirs or successors, except those which by these presents are reserved or ought to be paid to us, our heirs & successors;

Willing indeed, & by these presents firmly enjoining to be commanded, as well the Treasurer of our Chancery & the Barons of our Exchequer [+& those] of our heirs & successors, as the receivers, auditors & all other our officers & ministers [+& those] of our heirs & successors whatsoever for the time being, that they & any of them upon the only showing of these our letters patent or the enrolment of them without any other writ or warrant from us, our heirs or successors, in any wise to be obtained or prosecuted, will make & from time to time will cause to be made full, entire and due allowance & manifest discharge to the forenamed Robert Cecil & Hugh Beeston, their heirs & assigns, of all & all manner the same corrodies, rents, fees, annuities, pensions, portions, sums of money and all things whatsoever issuing or to be paid concerning the premises or any of the premises, as is mentioned previously,

And these our letters patent or the enrolment of them will be from time to time a sufficient warrant & discharge in this part, as well to the said Treasurer of our Chancery & the Barons of our Exchequer aforesaid [+& those] of our heirs & successors, as to all & singular the receivers, auditors & other our officers & ministers [+& those] of our heirs & successors whatsoever for the time being;

And further of our more ample grace for the foresaid consideration we will & grant by these presents for us, our heirs & successors, to the forenamed Robert Cecil & Hugh Beeston that these our letters patent & the enrolment of them will be firm, valid, good, sufficient & effectual in the law against us, our heirs & successors, as well in all our courts as elsewhere within our kingdom of England without any confirmations, licences or tolerations to be procured or obtained from us, our heirs or successors, hereafter by the foresaid Robert Cecil & Hugh Beeston or their assigns or any of them;

Notwithstanding the ill naming or ill reciting or not reciting the foresaid manors, messuages, mills, lands, tenements, rectories and the rest of the premises, or any parcel thereof;

And notwithstanding the ill reciting, ill naming or not reciting of any leases or grants or assurances of the premises or of any parcel thereof formerly made in fee tail for term of life or years or otherwise, being of record or not of record;

And notwithstanding the ill naming or the not true naming the towns, hamlets, parishes or counties in which the premises or any parcel thereof are, or in not naming of the premises;

And notwithstanding any defect of the true naming of the foresaid manors, messuages, rectories, lands, tenements & the rest of the premises or of any parcel thereof or the natures, kinds, species, quantities or qualities of them or of any of them;

Provided always that if the foresaid Edward Jones at the time of his attainder was seised or possessed for term of life or lives or years or otherwise of or in any lands, tenements or hereditaments in the said counties of Denbigh, Flint or Shrewsbury or in any of them whereof the reversion or remainder after any term of life, lives or years or otherwise belonged or appertained to us, our heirs or successors, that then these our letters patent, as far as such lands, tenements & hereditaments of which the reversion or remainder thus belongs or appertains to us, our heirs or successors, as is thus mentioned previously, might be entirely void & of no force in law;

And further know that we of our more abundant grace and of our certain knowledge & mere motion have given & granted and by these presents for us, our heirs & successors, do give & grant to the forenamed Robert Cecil & Hugh Beeston all & singular the same goods & chattels, as well moveable as immoveable, as well real as personal, sums of money, debts, annuities, yearly pensions, statutes, recognizances, bills obligatory & obligations whatsoever which we have or enjoy or will be able or ought to have, enjoy or recover by reason of the attainder of the said Edward Jones;

To have, hold, seise, levy, recover & enjoy the foresaid goods & chattels, as well moveable as immoveable, as well real as personal, sums of money, debts, annuities or yearly pensions, statutes, recognizances, bills obligatory & other obligations & any part & parcel thereof to the forenamed Robert Cecil & Hugh Beeston, their executors, administrators & assigns, to their proper behoof & use fully, freely & entirely, without account or any other thing therefore in any wise to be yielded or made to us, our heirs or successors, in as ample manner & form as we, our heirs or successors, or any of us, might or ought [+or] will be able or ought to have, receive, enjoy, take, seise, recover or grant the premises or any parcel thereof by reason or occasion of the foresaid attainer of the same Edward Jones;

We do give also and by these presents for us, our heirs & successors, do grant to the forenamed Robert Cecil & Hugh Beeston, their executors, administrators & assigns & any of them from time to time & at all times hereafter, for the better performance & execution of this our gift or grant, full power & authority to inquire into & discover or to make & cause to be inquired into & discovered by offices, inquisition or inquisitions and other lawful means whatsoever the right, title & interest which we have, have had, or ought to have to or in the premises by these presents beforehand granted or any parcel thereof thus by occasion of the foresaid attainer forfeited or belonging to us;

And that the foresaid Robert Cecil & Hugh Beeston, their executors, administrators & assigns will have full power & authority from time to time to release, acquit & discharge whatsoever persons & whatsoever person, their heirs, executors & assigns, of the foresaid goods & chattels, sums of money, debts, annuities or yearly pensions, statutes, recognizances, bills obligatory & obligations whatsoever by these presents granted beforehand and of any parcel thereof;

And that such release, acquittance or other discharge thereof thus by the forenamed Robert & Hugh Beeston, their executors, administrators & assigns, or any of them to be made will be in that part a sufficient bar, release, discharge & acquittance to be impleaded against us, our heirs & successors, of & for the premises by these presents beforehand granted, and as valid & effectual in the law as if the same were made by us, our heirs or successors or any of us;

And that the same Robert Cecil & Hugh Beeston, their executors, administrators & assigns, in the names of the said Robert Cecil & Hugh Beeston in their lives or in the name of their executors, administrators or assigns after the death of them, Robert & Hugh, or otherwise in our name [+& those] of our heirs or successors might be able to implead or prosecute whatsoever persons or whatsoever person in our Court of Exchequer or in our other courts [+& those] of our heirs or successors whatsoever for the levying & recovery of the foresaid goods & chattels, sums of money, debts, annuities, statutes, recognizances & bills obligatory, as is thus mentioned previously, by these presents beforehand granted & forfeited to us by the foresaid attainer of the same Edward Jones, as well by their bodies, goods & chattels as by their lands & tenements;

And that they might have power & be able to levy the foresaid goods & chattels, sums of money, debts, annuities, statutes, recognizances & bills of obligation and to make, take & prosecute execution thereof by the same manner & form as we, our heirs & successors, of our royal authority & in our proper name might have been able if this our present grant to the forenamed Robert Cecil & Hugh Beeston had not been made;

And moreover we will and by these presents for us, our heirs & successors, do grant that these our letters patent or the enrolment of them from time to time will be a sufficient warrant, as well to the Treasurer of our Chancery & the Barons of our Exchequer [+& those] of our heirs & successors as to the Remembrancer & to all other our officers & ministers [+& those] of our heirs & successors, not only to direct & to cause to be directed all & whatsoever our commissions, writs & process [+& those] of our heirs & successors for the inquiry, recovery & levying of the foresaid goods & chattels, sums of money, debts, annuities, statutes, recognizances, bills of obligation & the rest of the premises by these presents, as is thus mentioned previously, granted beforehand and forfeited to us by the attainer of the said Edward Jones, but also all others to be made & executed according to the tenor & effect of these our letters patent, and to pay & deliver to the forenamed Robert Cecil & Hugh Beeston, their executors or assigns, all such sums of money, as is thus mentioned previously, levied & recovered of or for the premises by these presents beforehand granted or any parcel thereof, without any account to be made or paid of the profits or any thing whatsoever to us, our heirs & successors;

We will also and by these presents do grant to the forenamed Robert Cecil & Hugh Beeston, their heirs, executors & assigns, that they might & will have these our letters patent under our Great Seal of England made & sealed by proper means without fine or fee, great or small, in any wise to be yielded, paid or made to us therefore in our Hanaper or elsewhere to our use. Although express mention etc. In [+testimony] of which thing etc. Witness the Queen at Westminster on the first day of July. By herself, the Queen.
