SUMMARY: The document below is the last will and testament, dated 12 October 1578 and proved 6 May 1579 of Elizabeth Peyton Wigston (d.1578), mother of Roger Wigston (c.1537 - 1608), at whose home, Wolston Priory, the last two Marprelate tracts, the *Theses Martinianae* and the *Just Censure and Reproof of Martin Junior*, were printed on a secret press in July 1589.

Sir John de Peyton died in 1394 and was succeeded by his son and heir John de Peyton who married Joan daughter and heir of Sir Hamon de Sutton of Wixoe Knt. by which marriage this place [=Peyton Hall] came to the Peytons. He had issue by his wife (afterwards married to Si Roger Drury Knt.), Margery wife of Thomas Daubeny of Sharrington co. Norfolk, three sons John, Thomas and Robert. . . .

And immediately after my debts, legacies and bequests, be paid and this my testament and will performed, that then I will John, my second son, shall have to him my manor in Barnham Saint Martyn called Calthorpes, as more plainly is specified in my will of my flocks of sheep going at Barnham aforesaid.

TESTATRIX' CHILDREN

According to the will below, the testatrix had four sons and five daughters:

* Roger Wigston (c.1537 – buried 28 September 1608), esquire, in whose house, Wolston Priory, the last two Marprelate tracts were printed in July 1589 (see above). He married Margaret Davenport (buried 15 September 1606), the daughter of Nicholas Davenport of Cheshire. See the following clause in the will of the testatrix' husband:

Item, I will that the said Dame Elizabeth Wigston, my wife, shall have, hold & peaceably enjoy my mansion house in Wolston . . . during the term and space of 3 years next and immediately after the death of me, the said Sir William Wigston, according as it is plainly expressed and declared in the indentures of covenants of marriage had and made betwixt the right honourable Lady Suzan Zouche, widow, & [-and] the said Sir William Wigston

for and concerning the marriage of Roger Wigston, son & heir of the said Sir William Wigston, then married to Margaret Davenport daughter of the aforesaid Lady Susan Zouche, bearing date the last day of May in the third year [=31 May 1561] of the reign of our most glorious Sovereign Lady Queen Elizabeth etc.;

He married Margaret, daughter of Nicholas Davenport of Cheshire, and by her had issue, a son, Huntingdon Wigston, who died young, and two daughters, i. Elizabeth, m. Nicholas Davenport, who thus recovered his lands in Fulshaw, was dead before 1560, in which year his son and heir, Humphrey Davenport, sold his lands there . . . The widow of Nicholas Davenport, described as "Susanna Lady Zouche, widow, late wife of Sir John Zouche, Knight, Lord Zouche," was also a party to the above sale.

By Margaret Davenport, Roger Wigston had three sons and two daughters:

In the name of God, so be it. I, Elizabeth Wigston, widow, being very weak in body yet, God be thanked therefore, of perfect mind and memory, ordain, constitute and make this my last will and testament in manner and form following:

First and principally I bequeath my soul to Almighty God, my (illegible) Maker and Redeemer, by whose death and passion is my only hope and trust of salvation, and my body from whence it came, as earth to earth, ashes to ashes and dust to dust (illegible) to be buried according to the discretion of my executor without any worldly pomp, considering my small ability;

Item, I give to the mother church of Lichfield 4d;

Item, to the parish church where I shall happen to depart, and there to be buried, 3s 4d;

Item, I give and bequeath unto my son Wigston my silver cup gilt with the Cleres' arms thereupon, and to Huntington Wigston after his decease;

Item, to Elizabeth Wigston, my god-daughter, I give and bequeath one pair of sheets of three breadths with the broad hems, and a pair of pillow-beres;

Item, I give and bequeath unto Susan Wigston my little spruce coffer and the sampler therein;

Item, I give and bequeath to my daughter, Anne Croftes, a damask board-cloth and a towel, and my forepart of black velvet;

Item, I give and bequeath unto my daughter, Christian Wake, a pair of sheets marked with the letter E, a pair of pillow-beres, a diaper board-cloth, six napkins, diaper, and a diaper towel, a waist smock, a reale(?) of calico cloth, and a chersne [=cushion?];

And to little Abraham Wake my gilt spoon;

Item, I give and bequeath to Mary Wigston, my daughter, my taffeta gown laid on with black and red lace, a forepart of fugure [=figured?] satin, my head that is whole behind and all that belongeth thereunto, my lawn partlet, and one iron-bound coffer with one lock;

Item, I give and bequeath unto Bridget Smith, my youngest daughter, my camlet gown, my round kirtle, my petticoat I wear every day, a pair of sheets of tyre of hemp, two pillow-beres, a coverlet lined with blue buckram and a little iron-bound coffer lined within with red leather:

Item, I give and bequeath unto my second son, Robert Wigston, a featherbed, a bolster, a blanket, a coverlet and a pair of sheets;

Item, I give and bequeath unto William Wigston, my third son, a stone jug covered with silver and gilt, and a piece of gold of 20s;

Item, I give and bequeath unto Edward Wigston, my youngest son, my gold ring, being my seal with E and W, and a piece of gold of 15s;

Item, I give and bequeath unto Joan Asley, my maid, my mourning gown, my silver spoon, and my little coffer where my ruffs lie;

Item, to Elizabeth Crosse, widow, I give and bequeath 10s in money;

Item, the rest of all my goods, household stuff, chattels, obligations and debts whatsoever, my funerals discharged and my debts paid, I give and bequeath to my well-beloved son-in-law, William Purefoy, whom I ordain and make my full and whole sole executor;
