SUMMARY: This list of licences issued for travel beyond the seas from 1572 to 1578 includes Oxford's licence to travel for one year issued in January 1575 (New Style) and a one year extension granted on 2 March 1576 (New Style). Since Oxford set out for England from Venice on 5 March 1576, the extension of his licence was likely a mere formality to cover the duration of his return trip to England. Nathaniel Baxter's verses published in 1606 indicate that the Queen had directed Oxford to return:

Vigilant then th' eternal Majesty . . . / Induced us to make speedy repair.

It is perhaps significant that, unlike Oxford's, most licences were issued for periods longer than one year.

Oxford's licence is preceded in the list below by a licence issued to William Russell, esquire, to travel for three years. William Russell (c.1553–1613) was later 1st Baron Russell of Thornhaugh and Lord Deputy of Ireland. For a letter dated 31 March 1576 from Dr Valentine Dale (c.1520-1589) to Lord Burghley mentioning Oxford's return to Paris in William Russell's company, see TNA SP 70/137, ff. 322-3.

The list also contains a licence to travel for one year issued to John Russell of Worcestershire on 11 February 1576. It seems likely that this was Sir John Russell (1552-1593) of Strensham, the elder half-brother of Thomas Russell (1570-1634), the supervisor of the will of William Shakespeare of Stratford upon Avon. If so, Oxford and Sir John Russell's continental tours overlapped by two months. Sir John Russell was brought up in the household of Francis Russell (1526/7-1585), 2nd Earl of Bedford, and had 'formed the closest ties' with his cousin, William Russell (c.1553-1613), mentioned above, the Earl of Bedford's youngest son, who arrived in Paris at the end of March 1576 in Oxford's company.
