SUMMARY: The document below is the Prerogative Court of Canterbury copy of the will, dated 31 May 1494 and proved 23 May 1495, of Sir William Calthorpe (30 January 1410 - 15 Nov 1494), whose daughter, Anne Calthorpe, married Sir Robert Drury (b. before 1456, d. 2 March 1535), lawyer and speaker of the House of Commons, and chief steward and executor to John de Vere (1442-1513), 13th Earl of Oxford.

The testator's granddaughter, Agnes Calthorpe, was the grandmother of Anthony Crane, husband of 'Mistress Crane' in whose manor of East Molesey the first of the Marprelate tracts was printed on a secret press in October 1588.

On Sir Oliver Calthorpe's death, the manor [Brome Hall] passed to his son and heir, Sir William Calthorpe, who married Eleanor, daughter of Sir John Mantly, and died in 1420, when the manor descended to his son and heir, Sir John Calthorpe, who married Amy,

daughter and heir of Sir John Wythe, and on his death the manor passed to his son and heir, Sir William Calthorpe, who, dying in 1494, left by Elizabeth, his first wife, daughter of Reginald, Lord Grey of Ruthyn, a son, Sir John Calthorpe, who married Elizabeth, daughter of Roger Wentworth, of Nettlestead, and died in his father's lifetime, and on Sir William's death the manor passed to his grandson and heir, the son of Sir John, Sir Philip Calthorpe, who married 1st Mary, sister and heir of Sir William Say, and 2ndly Jane, daughter of John Blenerhasset, and dying in 1535 the manor passed to his son and heir by his first wife, Sir Philip Calthorpe. He married Jane (? Amata or Amy), daughter of Sir William Boleyn, of Blickley, in Norfolk, and aunt of Queen Anne Boleyn, and died 7th April 1549, leaving an only daughter and heir, Elizabeth, married to Sir Henry Parker, K.B., son and heir of Lord Morley, who sold the manor in 1550 to Robert Hyde, from whom it passed to Sir Thomas Cornwallis, eldest son of Sir John Cornwallis.

Testator's parents

The testator was the son of Sir John Calthorpe of Burnham Thorpe by Anne Wythe, daughter of Sir John Wythe. According to the pedigree in Lee-Warner, *supra*, the testator had three sisters:

-(blank) Calthorpe, married successively to husbands surnamed Colville, Brandon and Bertie. According to some sources, her Christian name was Ada.

MARRIAGES AND CHILDREN

In the will below the testator mentions three sons of his second marriage, Francis Calthorpe, William Calthorpe and Edward Calthorpe, and three daughters, married to William Gurney, Robert Drury and Francis Hasilden, respectively. The testator died at the age of 84, and several of his children had predeceased him.

Testator's first marriage

The testator married firstly Elizabeth Grey (d.1437), the daughter of Sir Reynold Grey (c.1362 – 18 October 1440), 3rd Baron Grey of Ruthin, by his third wife, Joan Astley (d. 3 September or 12 November 1448). * **John Calthorpe**, esquire, eldest son and heir apparent, who married Elizabeth Wentworth, daughter of Roger Wentworth (d. 21 October 1452), esquire, by Margery Despenser (d. 20 April 1478), daughter and heiress of Sir Philip le Despenser (d. 20 June 1424). By Mary Say, Sir Philip Calthorpe (c.1464-1535) was the father of a son, Sir Philip Calthorpe (1480 - 7 April 1549), and three daughters, including Elizabeth Calthorpe (d. before 1518), who married firstly Sir Robert Southwell (d. 31 March 1514), and secondly Thomas Brooke (d.1529), 8th Baron Cobham. Elizabeth Calthorpe was the daughter of Sir Philip Calthorpe of Burnham Thorpe, Norfolk (c.1464-1535) and his first wife, Mary Saye (1464-1501). Her first husband was Sir Robert Southwell (d. March 31, 1514). She was his second wife. They were married c.1511 and had no children. In 1515, she became the second of three wives of Thomas Brooke, 8th baron Cobham (d. July 19, 1529). Her name is sometimes mistakenly given as Dorothy Southwell. A lawsuit in 1516 in the court of Common Pleas, identifies Lady Cobham as the widow of Sir Robert Southwell. She and her husband were at that time acting as co-executors of the Southwell estate. Elizabeth had no children from her second marriage and died before 1518.

Testator's second marriage

The testator married secondly Elizabeth Stapleton (d. 18 February 1505), elder daughter and co-heiress of Sir Miles Stapleton (d. 1 October 1466) by his second wife, Katherine de la Pole (1416 – 13 or 14 October 1488), daughter of Sir Thomas de la Pole by his second wife, Anne Cheyne, daughter of Nicholas Cheyne. Elizabeth Stapleton's sister, Joan Stapleton, married firstly Sir Christopher Harcourt, and secondly Sir John Huddleston (d. 1 January 1512). In Dei nomine Amen. I, William Calthorpe, knight, being in whole mind, the last day of May the year of Our Lord God 1494 make my testament in this form following:

First I bequeath my soul to God Almighty and to Our Lady Saint Mary and to all the holy company of heaven, and my poor body to be buried in the White Friars at Norwich where the place of my sepulture is made;

And the day of my burial I will be disposed to poor people to pray for my soul 40 marks in pence, and more need be;

Also I will and charge mine executors that all my debts be truly content and paid;

Also I will that restitution be made of such wrongs as I have done if any be duly proved;

Also I will that the White Friars aforesaid have 10 marks for the reparation of the church and of the place, and they to pray for my soul & my friends' souls;

Also I will that Friar Thomas Waterpipe sing for my soul and my wives' souls and my friends' souls by the space of 3 year at the altar where my sepulture is, and that after the Gospel he say openly at every Mass *De profundis* for my soul & the souls abovesaid, and that he shall have for the year for doing this divine service 6 marks yearly;

And if he do not this service aforesaid, I will that another friar well disposed be provided to the same service by mine executors, so alway that he that shall sing this Mass aforesaid for me and my friends take none other service nother [=neither] trental for the time;

Item, I will that the high altar of Saint Martin's in Norwich have 6s 8d to pray for my soul;

Item, to the reparation of vestments in the same church 40s;

Item, I bequeath to the high altar of Burnham Thorpe 6s 8d, and to the reparation of the church there 20s;

Item, to the high altar in Ludham 6s 8d, and to the church there 10s;

Item, to the church of Calthorpe 10s;

Item, to the house of Ingham 20s;

Item, to the guild of Saint George 20s;

Item, to the friars of Burnham 20s;

Item, to the house of Saint Benet's 40s:

Also I bequeath to the mother church in Norwich 40s;

Item, to the Grey Friars 20s;

Item, to the Friar Austins [=Augustinians] 20s;

Item, to the Black Friars 20s;

Item, to the nuns of Carrow 20s;

Item, to the sisters of Noraunys(?) 13s 4d;

Item, to every spital house in Norwich 20s;

Also I will that Dame Elizabeth, my right dearly-beloved wife, have all my plate and all my jewels and all that belongeth to her apparel which she or I have used or worn at any time, as well chains, rings, pearl, stones, beads, as all other things, except a piece of silver and gilt covered, a gilt spoon, and 6 spoons of silver which I will my cousin [=grandson], Philip, shall have, trusting that he will be helping to see this my testament and also my will be performed, and not to interrupt it, which God defend he should presume to do whereby he should fall in the great sentence of the church;

Also I will that my said wife have all my beds, hangings and all my goods and stuff of household that be or shall be the time of my death within my places at Norwich and Ludham and every of them not otherwise bequeathed nor given in my life;

Item, I will that my said cousin, Philip, have all the stuff of household which of mine remaineth at my place in Burnham;

Item, I will that my said cousin have 300 ewes, mother sheep;

Item, I will my son, Francis Calthorpe, have 200 mother sheep;

Item, I will my son, William Calthorpe, have 100 mother sheep;

Item, I will my son, Edward, shall have 100 mother sheep;

Item, I will that my son [=son-in-law] Gurney and my daughter, his wife, have 200 mother sheep;

Item, I will that my son [=son-in-law], Robert Drury, and my daughter, his wife, have 200 mother sheep;

Item, I will that my son [=son-in-law], Francis Hasilden, and my daughter, his wife, have 200 mother sheep;

Item, I will that Robert Clere, esquire, have 200 mother sheep;

Item, I will that Walter Aslack, gentleman, my servant, have 100 mother sheep;

Item, I will Lewes, my servant, have 20s;

Item, I will that Nicholas Blomevile, my servant, have 40s;

Item, I will that all my other servants be rewarded after their demerits by the good discretion of mine executors;

Item, I will that my house be kept by the space of a quarter of one year after my decease, and such as will serve shall have their wages for that time;

Item, I will that my said wife have the rule and finding of my son Hasilden and his wife till he come to the age of 21 years, and also she take the profit of all such manors, lands and tenements as I have be [=by] reason of such covenants as I have made with John Hasilden, esquire, unto the same time;

Item, I will that all the remnant(?) of the goods of Dame Sybil Lowes [sic for 'Boys'?] and of Master Richard Kegill(?) which amounteth [f. 183r] to the sum of £74 6s, whereof remaineth in the hands of Walter Aslack £24, and £6 13s 4d in the hands of my son, William Gurney, delivered to them by me, the said Sir William, and £6 remaineth in the hands of a man called Frire(?) of Anmer wherefore the said Walter Aslack hath obligation, of [sic for 'and'?] £37 12s 8d remaineth in mine hands at the time of the making of this my testament, of all which £74 6s I will that my said son Gurney and Walter Aslack have the disposition for making of the choir and presbytery at the Abbey of Creake;

And if any remain of the sum there not spended, then the overplus to be spent in other reparations upon the chapel within the same place where the ancestors of me, the said Sir William, lieth buried;

Also I will that the residue of my sheep and of all my other goods not above bequeathed be disposed for the weal of my soul and of my friends' souls;

And also all the revenues of my lands and tenements that shall be perceived be [=by] mine executors be also disposed after their discretion, whom I make and ordain the said Dame Elizabeth, my wife, Robert Clere, Robert Drury, William Gurney, Walter Aslack, whom I tenderly pray and require to see the profit and good execution of my will made and sealed and of this my testament in such wise as may be most for the weal of my soul after their discretion.

This is the last testament of me, Sir William Calthorpe.

[=The above-written testament was proved before the Lord etc. at Lambeth on the 23 day of the month of May in the year of the Lord the thousand 400 ninety-fifth, and probated etc., by the oath of Master Drury, Master Gurney and Dame Elizabeth, relict, etc., and administration was granted of all & singular the goods and debts of the said deceased to

the beforesaid Dame Elizabeth, relict & executrix named in the same testament etc., sworn on the Holy Gospels to well etc., and to exhibit a plain inventory etc. before the feast of Saint Peter next to come, with power reserved etc. to the other executors when they shall have come etc.]
