SUMMARY: The document below is the Prerogative Court of Canterbury copy of the will, dated 15 April 1534 and proved 19 November 1535, of Edward Scott (c.1478-1535?), esquire, whose son, William Scott, was the brother-in-law of Oxford's half sister, Katherine de Vere, and whose granddaughter, Ellen Wyborne, married Edward Windsor, grandson of Oxford's half sister, Katherine de Vere.

Testator's parents

The testator had one brother and three sisters, for whom see the will of his father, *supra*.

MARRIAGE AND ISSUE

The testator married Alice Fogge (c.1508 - c.1583), the daughter of Thomas Fogge (d. 16 August 1512), esquire, and Eleanor Browne. For the will of Thomas Fogge, see TNA PROB 11/17/267. For the will of Eleanor (nee Browne) Fogge Kempe, see TNA PRO 11/43/638.

Alice Fogge may have been the testator's second wife. In the will below he refers to her as 'Alice, now my wife'.

By Alice Fogge, the testator is said to have had one son and three daughters:

* William Scott (d. 25 January 1583), who married Mary Windsor, the daughter of William Windsor, (1498-1558), 2nd Baron Windsor, and sister of Edward Windsor

(1532?-1575), 3rd Baron Windsor, who married Oxford's half sister, Katherine de Vere (1538-1600). See the will of William Windsor, 2nd Baron Windsor, TNA PROB 11/42A/91. Mary Windsor's husband appears to have been the William Scott who was imprisoned in the White Lion, Southwark, as a Catholic recusant in 1582. See Surrey History Centre, 6729/10/52. The testator and his son, William Scott, are mentioned in entails in the will of the testator's nephew, Sir Reynold Scott (c.1511 - 16 December 1554), TNA PROB 11/37/539.

By Mary Windsor, William Scott had three sons and three daughters, including:

(1) William Scott (d. 11 December 1637), who is said to have married Mary Leveson, the sister of Sir Walter Leveson of Wolverhampton, Staffordshire. Thomas died in 1582, (fn. 26) and was succeeded by his eldest son Thomas Cheney, who sold the reversion of this manor, then leased to Robert Oxenbridge during the life of Anne widow of Thomas Cheney, (fn. 27) in 1586 to William Darrell. (fn. 28)

Elizabeth Shirley (c.1555-1624+) was the daughter of Francis Shirley of West Grinstead, Sussex (c.1524-March 20, 1577/8) and Barbara Blount (c.1538-February 28, 1563/4). They were a recusant family. Elizabeth's first husband, to whom she was married by 1582, was William Wyborne (Wyborn/Wybarn) of Hawkswell, Sussex (c.1540-c.1612). They do not appear to have had any children but took in the orphaned sons and daughters of his sister Ellen or Eleanor—John, Walter, William Margaret, and Mary Windsor.

LM: Test{amentu}m Edwardi Scott

In the name of God, Amen. I, Edward Scott of Iden in the county of Sussex, esquire, whole of mind and of body, thanked be God, the 15 day of April in the 25 year of King Henry the 8th ordain and make this my present testament in manner and form following:

First I bequeath my soul to Almighty God;

And my body to be buried where it shall please God that I shall depart;

Item, I bequeath to the high altar of the church [+of?] Iden for my tithes withholden 13s 4d;

Item, I will my executrice bestow at my outbearing, month's mind and year's mind, every time £3 6s 8d or thereabouts by her discretion;

Item, I bequeath to the church of Iden to the performing of the sealing [=ceiling?] of the said church 40s;

Item, to the gilding of the tabernacle of All-Hallows in the said church 20s;

Item, I bequeath unto Jane, my daughter, to be paid unto her on the day of her marriage forty pounds;

Item, I will unto the child which my wife now goeth with, if it be a daughter, to be paid to her at the day of her marriage twenty pounds;

Item, I will mine executrice have the custody, rule and governance of all my daughters till the day of their marriages;

Item, I bequeath unto every of my servants such reward as my wife think convenient by her discretion;

Item, I will that my executrice pay all such debts as I am indebted and owe at the time of my decease, and the same to be paid at in [sic for 'in as'?] convenient and short time after my decease as she can or may;

Item, I bequeath Ingram Avanne(?) his servant one couple of oxen;

Also unto Robert Alice two kine;

And unto Thomas Maynard one cow;

The residue of all my goods and chattels, my debts contented and paid and this my present will performed and fulfilled, I will and bequeath unto Alice, my well beloved wife, the which said Alice of this my present testament and last will I ordain and make my true and faithful executrice;

And I ordain and make Walter Hendley, gentleman, and Thomas Foster to be supervisors and overseers of the same;

Item, I bequeath to every of my overseers of this my testament for their labours 20s.

This is the last will of me, the said Edward Scott, made the day and year above-written concerning all my manors, lands and tenements, rents and services:

First I will that my father's feoffees shall stand and be seised after my decease of and in the manor of the Mote, Ryver and Flote with all my other lands and tenements within the county of Sussex with all their appurtenances to the use of Alice, now my wife, during all the term of her life in the name of her jointure and toward the keeping of my daughters till they be married, these being witness: Walter Hendley, Thomas Foster, Ingram Avan(?), Robert Alice and other.

[=The above-written testament was proved on the 19th day of the month of November in the year of the Lord the thousand five hundred 35th at London before the Lord by the authority of our Lord King Henry the Eight, King of England & France etc., of Edward Scott, deceased, together with the last will of the same, having etc., by the oath of Alice Scott alias Oxenbridge, relict & executrix named in the same testament, and by the same authority of the said our Lord the King probated and entered, and administration was granted of all & singular the goods, rights and credits of the said deceased to the forenamed executrix in the person of John Howe, her proctor in that behalf, sworn on the Holy Gospels in due form of law to well & faithfully administer, and to exhibit a full & faithful inventory on the second day after the feast of Saint Blaise, Bishop, next to come, and also to render a plain & true account.]
