SUMMARY: The document below is the Prerogative Court of Canterbury copy of the will, dated 27 February 1550 and proved 5 August 1551, of Robert Crane (c.1487-1551), esquire, of Chilton, Suffolk, whose son, Anthony Crane (d.1583), was the husband of 'Mistress Crane' at whose manor of East Molesey the first of the Marprelate tracts was printed on a secret press in October 1588. The testator's sister, Elizabeth Crane, married Richard Martyn, a first cousin of Sir Roger Martyn, father of Humphrey Martyn (d.1587?), the addressee of the *Langham Letter* which describes Leicester's entertainment of Queen Elizabeth at Kenilworth in the summer of 1575. Testator's grandparents

The testator was the grandson of Robert Crane (d. after 1452), who married firstly Agnes Singleton, the daughter of Thomas Singleton of Stonham Jernegen, and secondly Agnes Grene, the daughter of Thomas Grene, gentleman, of Cretinge, Suffolk. It is unclear

whether the testator's grandmother was Agnes Singleton or Agnes Grene. See Appleton, *supra*, p. 59.

Testator's parents

The testator was the son of John Crane (d. 12 August 1504) and Agnes Calthorpe, widow of William Curson, sister of Sir Philip Calthorpe, and daughter of John Calthorpe and Elizabeth Wentworth, the daughter of Roger Wentworth (d. 24 October 1452), esquire, and Margaret le Despenser (d. 20 April 1478). For the will, dated 27 March 1532 and proved 7 April 1535, of Sir Philip Calthorpe, see NRO Platfoote 197. Sir Philip Calthorpe was the father-in-law of Amata Boleyn, aunt of Queen Elizabeth I, and the nephew of Anne Calthorpe, the wife of Sir Robert Drury (before 1456 - 2 March 1535), lawyer and speaker of the House of Commons, and chief steward and executor to John de Vere (1442-1513), 13th Earl of Oxford. See the will, dated 1 May 1531 and proved 8 February 1536, of Sir Robert Drury, TNA PROB 11/25/467.

Testator's siblings

The testator had two brothers and a sister:

-Edward Crane of Stratford, Suffolk, for whose will, proved 14 May 1558, see TNA PROB 11/40/252.

-John Crane, who died without issue.

-Elizabeth Crane, who, as noted above, married, as his second wife, Richard Martyn (d. 1 September 1572), the son of Roger Martyn (d.1542?) the elder of Long Melford, Bencher of Lincoln's Inn. Elizabeth Crane's husband, Richard Martyn (d. 1 September 1572), was a first cousin of Sir Roger Martyn (d.1573), father of Humphrey Martyn (d.1587?), the addressee of the *Langham Letter*. The testator was heir to his uncle, Robert Crane (d. 24 October 1500?), esquire, who died without surviving male issue. See the inquisitions post mortem taken after the deaths of Robert Crane, TNA C 142/15/40, and John Crane, TNA C 142/18/60, and the will, proved 16 May 1521, of Robert Crane's widow, Anne Ogard Arundell Crane, TNA PROB 11/20/165.

Robert Crane, heir of William, was of Stonham, and Chilton, which he inherited from his mother. He had two wives, Agnes, daughter of Thomas Singleton of Stonham, and Agnes, daugher of Thomas Greene of Creating. It is a little uncertain which was the mother of his children, but the evidence seems to incline in favor of the former. He died after 1452, and left two sons, Robert and John, both under age.

Robert Crane, elder son and heir, of Chilton, married first in 1465 Katherine, daughter of Robert Darcy of Malden, Essex. She died childless, and he married secondly Anne, daughter of Sir Andrew Ogard, of Old Buckenham, Norfolk, Knight, widow of Sir Renfrey Arundell, Knight. She bore three children, George, who died in 1491 without issue, Elizabeth, who was Abbess of Brusyerd, and Margery, heiress to her father, who became wife of Thomas Appleton of Little Waldingfield, Suffolk, and died 4 November 1504; from whom are descended the Appletons of Ipswich, Massachusetts. Robert Crane died 24 October, 1500, and Lady Arundell, his widow, in 1521.

John Crane, brother of Robert, was of Stonham, and afterwards of Chilton also. His wife was Agnes, daughter of John Calthrop of Norfolk, by whom he had four children, Robert, Edward and John, both of whom died childless, and Elizabeth, who married Richard Martin of Melford. He died 12 August 1504.

Robert Crane, heir of John, born about 1487, inherited Chilton and all the estates of the family.

The testator married firstly Elizabeth Southwell, the daughter of Richard Southwell of Woodrising, Norfolk, and his second wife, Katherine Williams, daughter of John Williams, esquire, and widow of a husband surnamed Sturges. Second marriage of the testator's eldest son, Robert Crane (c.1508 – 12 September 1591)

The testator eldest son and heir, Robert Crane (c.1508 – 12 September 1591), married secondly a wife named Elizabeth, by whom, according to the Crane pedigree in *The Visitation of Suffolke*, *supra*, pp. 163-4, he had three daughters:

- * Anne Crane (d.1608), who married Ralph Choppin (d.1588) of Goddenham.
- * Agnes Crane, who married firstly John Smith of Halesworth, secondly Sir Christopher Heydon of Baconsthorpe, and thirdly Sir Edward Clere (d.1606) of Blickling.

* Mary Crane, who married Dudley Fortescue, esquire.

Third marriage of the testator's eldest son, Robert Crane (c.1508 – 12 September 1591)

The testator's eldest son and heir, Robert Crane, married thirdly Bridget Jermyn, the daughter of Sir Thomas Jermyn (d.1552) of Rushbrook, Suffolk. Testator's second marriage

The testator married secondly Jane White, the daughter of Edward White of Essex, widow of Thomas Christmas, by whom, according to the Crane pedigree in *The Visitation of Suffolke*, *supra*, pp. 163-4, he had a son and three daughters:

- * **John Crane** of Norfolk, who married Margery Pinder, the daughter of William Pinder, gentleman, of Norfolk.
- * Elizabeth Crane, who married Edmund Markaunt, gentleman, of 'Semer'.
- * Anne Crane, who died unmarried.
- * Grissel Crane, who married Robert Bogas of Braham Hall in Brantham.

In the name of God, Amen. Be it known unto all the faithful congregation of Christ's church that upon the 27 day of the month of February and in the fourth year of the most gracious reign of Edward the Sixth by the grace of God of England, France and Ireland King, Defender of the Faith, and immediately next under God of the Church of England and Ireland the Supreme Head, that I, Robert Crane of Chilton within the county of Suffolk, esquire, being whole of mind and of good and perfect memory, thanks be unto Almighty God, doth institute and ordain this to be my firm and last will, that is to say:

First I commend my soul unto th' hands of my Lord God, my Redeemer and Maker, the which is my only comfort and refuge, for in him is all my whole faith and trust, and my body to be buried in the parish church of Chilton, or else where it shall please my Lord God to call me unto his mercy;

Item, I will that mine executor shall honestly bring me unto my sepulture or grave at the day of my burial according to my degree, and to distribute and give the same day amongst poor people as it shall seem meet and convenient by his discretion;

Item, I give unto the parish of Newton to be bestowed amongst the poor people 6s 8d;

Item, I do give to the parish of Much Waldingfield 6s 8d;

Item, I do give unto the three parishes in Sudbury to be bestowed amongst the poor people ten shillings to every parish;

Item, I do give to the said parish of Acton amongst the poor people four shillings;

Item, I do give to the parish of Much Cornard to be given amongst the poor four shillings;

Item, I do give to every household [f. 155r] in Chilton 8d apiece;

Item, I will that Anthony Crane, my son, shall have of my gift to him during his life natural one annuity of ten marks yearly going out of all that manor, lands, tenements, meadows and pastures which I late bought and purchased of John Southwell, esquire,

being and lying within the town of Codnaham [=Coddenham?] within the county of Suffolk with a clause of distress for non-payment to be made unto him by the consent of Robert Crane, my son, as by the learned counsel of the same Anthony shall be reasonably devised;

Item, I do give and bequeath to Anthony Crane, my son, two hundred marks, and unto John Crane, my son, one hundred marks of the debt that one Thomas Patmer(?) oweth me, to be received unto each of them as it may be levied, that is to say, Anthony Crane to [-to] receive two parts and John Crane one part at every payment;

Item, I do give unto Dorothy Baxter, my daughter, ten pounds of lawful money;

Item, I do give unto Elizabeth Markaunte, my daughter, twenty pounds of lawful money;

Item, I bequeath unto Anne, my daughter, wife unto Ambrose Coole [=Cole?], twenty pounds of lawful money;

Item, I give and bequeath unto Grissel and Agnes, my daughters, unto each of them one hundred pounds to be paid at the days of their marriage so that they be ruled and ordered by the discretion(?) and consent of mine executor, and if they will not be ruled by their friends by choosing of their husbands, but to take whom they list, then this my gift to stand void and of none effect;

Item, I do give unto John Crane, my son, my two gowns of cloth guarded with velvet and my doublet of tawny satin;

Item, I do give Pernell Armiger, my servant, ten pounds of lawful money to be paid unto her at the day of her marriage;

Item, I do give very manservant of my house taking wages 3s 4d, and to every woman servant [check] having my wages 3s 4d;

The residue of all my goods movable and unmovable I give and bequeath them into th' hands of mine executor, Robert Crane, my son, whom I do now institute and ordain him to be my sole executor to see that this my last will and testament shall of his part be well and truly performed and kept as he will answer before God at the last day;

And these be the witnesses of this my last will and testament as hereafter doth follow, and to this will I put my seal the day & year above-written. Sir Robert Goodale, clerk, John More, John Crosse, Robert Sapbye, Robert Smythe, William Warmer(?), Robert Man.
