SUMMARY: The document below is the Prerogative Court of Canterbury copy of the will, dated 26 September 1561 and proved 12 November 1561, of Reginald (or Reynold) Newport of Sibdon Carwood, Shropshire, brother of Sir Richard Newport (d. 12 September 1570), owner of a copy of Hall's *Chronicle* containing annotations thought to have been made by Shakespeare. The volume was Loan 61 in the British Library until 2007, was subsequently on loan to Lancaster University Library until 2010, and is now in the hands of a trustee, Lady Hesketh. According to the Wikipedia entry for Sir Richard Newport, the annotated Hall's *Chronicle* is now at Eton College, Windsor. See:

Testator's parents

The testator was the son of Thomas Newport and Anne Corbet. For the will of Thomas Newport, dated 24 July 1548 and proved 11 June 1551, see TNA PROB 11/34/176.

The testator's mother, Anne Corbet, was the daughter of Sir Robert Corbet (c.1477 – 11 April 1513) by Elizabeth Vernon, the daughter of Sir Henry Vernon (c.1441 – 13 April 1515) of Haddon, Derbyshire. Testator's siblings

As noted above, the testator's brother, Sir Richard Newport, was the owner of a copy of Hall's *Chronicle* containing annotations thought to have been made by Shakespeare.

The testator's sister, Elizabeth Newport, married John Pakington (1530-1578), and was the aunt of Humphrey Martyn (d.1587?), the addressee of the *Langham Letter* describing Leicester's entertainment of Queen Elizabeth at Kenilworth in the summer of 1575. See the Langham page on this website.

MARRIAGE

The testator married Elizabeth Banastre, daughter of Edward Banastre, and widow of a husband surnamed Perott, by whom he had no issue. In his will the testator refers to his wife as deceased, and leaves bequests to Edward Perott, Mary Perott, Dorothy Perott, Thomas Perott, Jane Perott and William Perott, her children by her first husband.

First I bequeath my soul to Almighty God etc.;

Item, I give and bequeath unto Stephen Rice, my servant-boy, one weanling calf coloured red;

Item, I give and bequeath unto Hugh Newport, my brother, 20 French crowns being in the hands of Edward Bannester, my father-in-law, to be paid by my said father-in-law unto my said brother, Hugh, at such times as my said father-in-law may conveniently pay them;

Item, I give & bequeath unto my brother, Andrew Newport, my signet of gold;

Item, I give and bequeath unto Joyce Broke, daughter of Francis Broke, one ring of gold with a ruby stone;

Item, I do ordain and make my executors Edward Bannaster, esquire, my father-in-law, and Edmund Newport, my brother, my lawful executor;

Item, I give and bequeath unto Rice ap Howell my white salt;

Item, I give unto William Painter my dagger;

Item, I give and bequeath unto Elizabeth Broke, my late wife's aunt, my purse and the money in the same being in her custody towards her charges & pains;

Item, I give to John Corbet of Sibdon my black frizado coat. Reginald Newport. Witness at the making of this will, Francis Broke, John Burges, William Painter, Rice ap Howell.

Debts that I owe: to John Shery 4 marks; to the parson of Hopton 20s.
