SUMMARY: The document below is the Prerogative Court of Canterbury copy of the undated will, proved 4 November 1458, of the London mercer, John Rich, who died 29 July 1458, predeceasing his father.

The testator was the great-grandfather of Lord Chancellor Richard Rich (d.1567).

The testator was the son of the London mercer, Richard Rich (d.1464), and his wife, Katherine. Richard Rich, who was of the Company of Mercers of the city of London and executed the office of Sheriff of that city anno 1441 in the 20<sup>th</sup> of Henry VI, and founded a certain alms-house at Hoddesdon in county Hertford, which Richard, writing himself of London mercer, made his will April 20, 1463, 3 Edward IV, ordering his body to be buried in the chapel of the blessed St. Mary within the church of St Lawrence in the Old Jewry, London, near his seat in that church, and that his funeral be performed without any pomp. He appointed Katherine, his wife, Thomas, his son, Robert Love, his chaplain, William Marrow, John Walden, alderman of London, and Thomas Urswick, Recorder of London, who had married his daughters, and their servants, to be clothed by Thomas, his son, in black cloth of the value of 2s 6d per yard to attend the day of his burial.

## Testator's siblings

The will of the testator's father establishes that the testator had a brother and three sisters:

- -Thomas Rich (d.1475), who married Elizabeth Croke (d.1479), the daughter of John Croke, alderman of London. In his will, dated 2 July 1471 and proved 17 October 1475, TNA PROB 11/6/296, he left £20 towards the marriage of his nephew, Thomas Rich, 'son of John Rich, sometimes my brother'. After the death of Thomas Rich, Elizabeth Croke married secondly John Fenne (d. 3 September 1474), and thirdly, in 1475, Sir William Stonor (d. 21 May 1494). - **-Isabel Rich**, who married Sir Thomas Urswick (d. 19 March 1479), by whom she had four sons and eight daughters. See the *ODNB* entry.
- **-Margaret Rich**, who married John Walden (1410-1464), alderman and grocer of London, by whom she was the mother of Katherine Walden, who married John Tyrrell (d. 25 October 1494) of Beeches in Rawreth, Essex. 7 Sept., 4 Edward IV. [A.D. 1464], came Margaret, widow and executrix of John Walden, late Alderman, and surrendered her estate and interest in the tenement granted to her late husband in the preceding February. Thereupon the Mayor and Aldermen granted her a lease of the same tenement for a term of 4 years at the same rent as formerly. (fn. 1)

Although the *Calendar of Letter-Books* states that Margaret (nee) Rich Walden was her husband's executrix, his will does not appear to be extant.

## MARRIAGE AND ISSUE

The testator married Isabel Pulter, by whom he had three sons:

- \* Richard Rich (d.1469/70), eldest son, who married Joan Dingley [=Dyneley?], by whom he had three sons, Richard Rich, Robert Rich and Hugh Rich, and died in 1469-70. It seems almost certain that Richard Rich (d.1469/70) was the grandfather of Richard Rich (1496/7 12 June 1567), Lord Chancellor of England, by reason of the fact that the Lord Chancellor's residuary legatee was Edward Rich (d.1599) of Horndon, the grandson of the testator's second son, Thomas. - \* Thomas Rich, second son, who married Margaret Shaa, the daughter of Sir Edmund Shaa, Lord Mayor of London. For the will of Sir Edmund Shaa, see TNA PROB 11/8/187.

By his wife, Margaret Shaa, the testator's second son, Thomas, had a son, Thomas Rich (d. 3 March 1531) of South Weald, Essex, who married Rachel Newburgh, the daughter of Thomas Newburgh, esquire, of Berkley, Somerset, and is said to have had a daughter, Katherine Rich, who married firstly a husband named Barker, and secondly Sir Ralph Wiseman of Rivenhall, Essex. The testator appoints his brother-in-law, John Pulter of Hitchin, Hertfordshire, as one of his executors. In his own will, TNA PROB 11/8/47, dated 18 June 1485, John Pulter mentions several persons named in the will below, including the testator's wife, Isabel, the testator's second son, Thomas Rich, and the testator's sister-in-law, Anne Alburgh [=Albury?]:

In the name of God, Amen. I, John Riche, citizen and mercer of the City of London, whole of mind, blessed be God, make, ordain and dispose my present testament in this wise:

First I bequeath my soul to Almighty God, Our Lady Saint Mary, and to all the whole company of heaven, and my body to be buried in the church of Saint Thomas of Acres in London before Saint Thomas' shrine there, and I bequeath to the same place £10;

Also I will that mine expenses funeral be made with 12 torches and 4 tapers, of the which 12 torches I will that 2 be given unto the said church there to serve at Saint Thomas' altar in the body of the said church, also [sic?] long as they will endure;

Also I bequeath to the high altar of Our Lady of the Bowe 40s & 2 torches of the said 12 to be occupied and spent at the said high altar;

Item, I bequeath to the Trinity altar in the said church of Our Lady of the Bowe 2 torches of the same 12;

And I bequeath to the altar of Our Lady of Pity in the said church 2 torches;

And I bequeath to the altar of Saint Nicholas in the said church 1 torch;

Item, I bequeath to the house of lepers at Kingsland beside Hackney 6s 8d;

Item, I bequeath to the lepers at the lock without Saint George's Bar in Southwark 13s 4d;

Item, I bequeath to the nuns of Holywell 6s 8d;

Item, I bequeath to the nuns of Clerkenwell 6s 8d;

Item, I bequeath to the nuns at Stratford of the Bowe 20s;

Item, I bequeath to my cousin, Dame Alice Clerk, being in the said house, 20s;

Item, I bequeath to the prior and convent of the Charterhouse at Sheen as much linen cloth as will repair and serve to make of new ornaments for all the altars being in the church of the said Charterhouse;

Item, I bequeath to mine aunt dwelling in Hoddesdon every year while she liveth 20s;

Item, I bequeath to the almsmen being in my father's almshouse in Hoddesdon, to every of them 1 gown of cottoned cloth and 3s and 4d in money;

Item, I bequeath to Thomas, my [f. 108v] brother, my best gown and my best hood;

Item, I bequeath to every child of Thomas Urswick, Recorder of London, that is to say, Katherine, Avice(?) and Margaret, 5 mark for a cup to be bought at their marriage;

Item, I bequeath to my mother my tablet of gold;

Item, I bequeath to my father my signet of gold;

Item, I bequeath to the high altar of Our Lady of the Bowe for blue cloth of gold to be bought according to Malvern suete(?) of the price of £20 to serve to hang afore the altar there;

Item, I bequeath to Anne Malvern £5 for a cup to be bought at her marriage;

Item, to John Malvern for a cup to be bought at his marriage £5;

Item, I bequeath to Johanna Pulter for a cup to be bought at her marriage £4;

Item, I bequeath to Thomas Elys of [ ] 30s which that he oweth to me;

Item, to remember John Marshall, mercer, for to reckon between him and me as he will answer tofore God;

And I make and ordain mine executors Isabel, my wife, John Pulter of Hitchin, and John Albourgh [=Albury?], and I make mine overseer John Lok, mercer of London, these being witness: William Durraunt, Nicholas Muston and Nicholas Bevile.
