**Issues of the lands by the inquisition**

But received of **£32** resulting or arising from the issues of the manor of Hormead with the appurtenances in the foresaid county of Hertford of the yearly value of **£32**, held together with the manors of Roseworthy, Tregenna, [+&] Bejowan in the county of Cornwall and with others, but of whom (s. & pl.) is unknown, of which certain manor & the rest of the premises the foresaid John, late Earl of Oxenford, a long time before his death was seised among others, as before in the account of the honour, castle, & manor of Hedingham in the county of Essex more fully appears, and the same Earl by the foresaid indenture among other things granted, promised, granted [sic] & completely agreed to & with the forenamed Thomas, Duke of Norfolk, Robert, Lord Dudley, & Thomas Golding & their heirs as before is specified at large in the account of the manors of Waltons in Purleigh & Waltons in Mucking and the manor of Gobions in East Tilbury, parcel of the foresaid inheritance in the county of Essex, in the section "Issues of the lands by the inquisition".

**And the foresaid late Earl** by a certain deed of his sealed by his seal at arms & subscribed by his own hand dated the 16<sup>th</sup> day of May in the 38<sup>th</sup> year [=16 May 1546] of the reign of the late King Henry VIII in consideration that Thomas Phillips of Norwich & Joan his wife had surrendered to the forenamed late Earl two several annuities at the yearly value of 20 marks sterling by him, the late Earl, granted to the forenamed Joan under the description of Joan Constable, granted to the said **Thomas Phillips & Joan his wife** a yearly rent of **20 marks** of good & lawful money of England issuing of his manor of Great Hormead with its appurtenances in the said county of Hertford, to have the said annuity to the forenamed Thomas & Joan & the survivor of them, to be paid yearly at the feasts of the Annunciation of Blessed Mary the Virgin & Saint Michael the Archangel by equal portions by the hands of the said late Earl or his heirs or by the hands of the receiver, surveyor, or bailiff of the foresaid manor, the first payment to be begun at the feast of Saint Michael the Archangel next after the date of the foresaid deed, with a clause of distraint for non-payment of the foresaid annuity, as by the foresaid deed specified in the foresaid inquisition appears.

And it remains in the hands of the Lady Queen as before in the account of the honour, castle, & manor of Hedingham in the county of Essex, parcel of the foresaid inheritance,

more fully appears, and in the whole as above is valued by year by the foresaid inquisition, to be paid at the feasts of the Annunciation of Blessed Mary the Virgin & Saint Michael the Archangel equally, viz., for two such feasts falling within the time of this account.
