**Issues of the lands by the inquisition**

Not yet received of any profit resulting or arising from the issues of the foresaid manors of Wennington & Kennington with the appurtenances in the foresaid county of the yearly value of **£48**, held together with the foresaid manor of Countesmead in Bumpstead with the members & others in the foresaid county of Essex but of whom (s. & pl.) or by which services is unknown, and of the foresaid manor of Shottesbrook with the appurtenances in the foresaid county of Berkshire of the yearly value of (blank), held together with the manors of Roseworthy, Tregenna & others in the county of Cornwall & elsewhere in other counties but of whom (s. & pl.) is unknown, because the foresaid late Earl, being seised of & in the foresaid manors with the appurtenances & the rest of the premises among other things in his demesne as of fee, a certain fine was levied, as above in the foresaid account of the foresaid honour, castle, & manor of Hedingham in the foresaid county of Essex is specified, and after by a certain Act of the Parliament held, as in the same account similarly appears.

**And the foresaid late Earl** further by the foresaid indenture specified above in the account of the foresaid manor of Tilbury in the foresaid county of Essex for himself & his heirs completely & fully granted to & with the forenamed late [sic] Duke of Norfolk, Robert, Lord Dudley, & Thomas Golding & their heirs that he, the late Earl, his heirs & assigns, from the time of the making of the said indenture would stand & be seised of & in the reversion after the death of Robert de Vere of the foresaid manors of Kennington & Wennington in the foresaid county of Essex, and of & in the reversion of the foresaid manor of Shottesbrook in the county of Berkshire, and of & in the reversion of all & singular [+his] messuages, lands, tenements, rents, reversions, possessions, & hereditaments whatsoever situate, lying, & being in Kennington & Wennington in the said county of Essex and in Shottesbrook & elsewhere in the said county of Berkshire after the death of the said Robert Vere to the use of the same late Earl for term of his life without impeachment of any waste, and after his decease then to the use of Edward, now Earl of Oxenford, and of the heirs males of his body lawfully begotten, and for lack of such issue then to the use of the heirs males of the body of the same late Earl lawfully

begotten, and for lack of such issue then to the use of the said Aubrey Vere for term of his life, and after his decease to the uses as in the foresaid indenture at large is specified, and for lack of such issue to the use of the right heirs of the said late Earl forever, as by the foresaid indenture specified in the foresaid inquisition more fully appears, and the same late Earl thus of the same reversion being seised, died thereof seised.

And they remain in the hands of the said Lady Queen as above in the foresaid account of the foresaid honour, castle, & manor of Hedingham more fully appears, and in the whole as above are valued by the foresaid inquisition, to be paid at the feasts of the Annunciation of Blessed Mary the Virgin & Saint Michael the Archangel equally, viz., for two such feasts falling within the time of this account because [sic?] the foresaid Robert de Vere still survives & is in full life.
