Issues of the lands by the inquisition

Not yet received of any profit resulting or arising from the issues of the foresaid manor of Great Canfield with the appurtenances in the foresaid county of the yearly value of **£35 4s 2d**, held together with the foresaid manor of Tilbury juxta Clare with others in the foresaid county but of whom (s. & pl.) & by which services is unknown, because together with the foresaid manors of Wivenhoe, Newers, & Battleswick and with other manors, lands, & tenements here after specified below, the foresaid manor with the appurtenances is assigned towards the performance of the last will of the foresaid late Earl, so by the foresaid Act of Parliament above specified at large in the account of the honour, castle, & manor of Hedingham in the foresaid county of Essex as by the foresaid indenture above similarly specified in the account of the foresaid manors of Wivenhoe, Newers, & Battleswick in the foresaid county, for the term of 20 years next following after the death of the foresaid late Earl,

And the foresaid late Earl by a certain deed of his sealed by his seal at arms & subscribed by his own hand bearing date the 25th day of October in the second year [=25 October 1560] of the reign of the Lady Elizabeth now Queen for & in consideration of good, true, & faithful service by **John Wiseman**, gentleman, to himself previously done & thereafter to be done gave & granted to the same John Wiseman the office of bailiwick & bailiff of all & singular the rents & reversions, profits, & other hereditaments & possessions of his manor of Great Canfield in the county of Essex, and made & appointed him, John Wiseman, bailiwick of the foresaid manor, to have & enjoy the foresaid office to the forenamed John Wiseman by himself or by his sufficient deputy or his sufficient deputies for term of the natural life of himself, John, and the foresaid late Earl by his foresaid deed in consideration aforesaid gave to the same John Wiseman for exercising & occupying the foresaid office a wage & fee of **60s** of good & lawful money of England issuing of the foresaid manor at two terms of the year, viz., to be paid yearly at the feasts of the Annunciation of Blessed Mary the Virgin & Saint Michael the Archangel by equal portions during the term of the natural life of the said John Wiseman, as by the same deed specified in the foresaid inquisition more fully is clear & appears,

And the foresaid late Earl by a certain other deed dated the 10th day of November in the 36th year [=10 November 1544] of the reign of the late King Henry VIII for & in

consideration of good, true, & faithful service to him by **Robert Harvey** previously done & hereafter to be done gave & granted to the same Robert Harvey the office of warden of his park & bailiff or bailiwick of his manor of Great Canfield in the county of Essex, to have, hold, occupy, & enjoy the foresaid office with the appurtenances to the forenamed Robert Harvey by himself or by his sufficient deputy or his sufficient deputies from the day of the date of the foresaid deed during the whole term of the natural life of himself, Robert Harvey, and the foresaid late Earl by the foresaid deed in consideration aforesaid gave & granted to the foresaid Robert Harvey for exercising & occupying the foresaid office a certain annuity or yearly rent of **£6 20d** sterling, to be paid yearly at the feasts of the Annunciation of Blessed Mary the Virgin & Saint Michael the Archangel by equal portions during the natural life of the foresaid Robert Harvey, and the foresaid late Earl further by the foresaid deed granted that for non-payment of the foresaid annuity or yearly rent it would be well allowed to the forenamed Robert Harvey & his assigns to distrain in the foresaid manor, as by the foresaid deed specified in the foresaid inquisition more fully is clear & appears.

And the foresaid late Earl by another deed of his sealed by his seal at arms bearing date the 10th day of December in the 22nd [sic] year [=10 December 1530] of the reign of the late King Henry VIII granted to **John Wiseman** & Thomas Wiseman, his son, for his good counsel by the said John Wiseman to him done the office of auditor of all & singular the receivers, bailiffs, & other ministers or accountants whatsoever of all manner of all & singular castles & hereditaments whatsoever, and made & appointed them, John Wiseman & Thomas, auditors of all & singular receivers for all [+his] castles, lordships, & hereditaments within the kingdom of England, to have the foresaid office to the forenamed John & Thomas Wiseman by himself or by his sufficient deputy in accordance with & according to the laws of England from time to time during the life of them and also of the survivor of them to hear, determine, & to direct to an end, and the foresaid late Earl moreover granted to the forenamed John & Thomas for exercising the said office during his natural life and also the survivor of them a certain yearly rent of **£20** sterling issuing of his manor of Great Canfield in the county of Essex to them or the survivor of them or to their deputy by the hands of the bailiff & farmer of the foresaid manor to be paid yearly at the feast of All Saints together with all fees & payments to the same office owed & accustomed etc., with a clause of distraint if default might be made in payment as is aforesaid, as by the said deed specified in the foresaid inquisition more fully is clear & appears.
